

## **Aytu BioScience Common Stock Resumes Trading under Symbol 'AYTU' Today**

Temporary Ticker Symbol 'AYTUD' is No Longer Active as of September 28, 2017

ENGLEWOOD, Colo., Sept. 28, 2017 — Aytu BioScience, Inc. (OTCQX: AYTU), a specialty life sciences company focused on global commercialization of novel products in the field of urology, today announced that its permanent trading symbol of 'AYTU' has resumed trading and is reflective of the previously enacted stock split.



Following the stock split, which began trading on a post-split basis on August 29th, the company's common shares were trading under the symbol 'AYTUD.' Effective today, Aytu BioScience common shares have resumed trading on OTC Markets under the ticker symbol 'AYTU.' The ticker symbol 'AYTUD' is no longer active.

Aytu BioScience is a commercial-stage specialty life sciences company focused on global commercialization of novel products in the field of urology, with a focus on products addressing vitality, sexual wellness, and reproductive health. The company currently markets two prescription products in the U.S.: Natesto®, the first and only FDA-approved nasal formulation of testosterone for men with hypogonadism (low testosterone, or "Low T") and ProstaScint® (capromab pendetide), the only FDA-approved imaging agent specific to prostate specific membrane antigen (PSMA) for prostate cancer detection and staging. Additionally, Aytu is developing MiOXSYS®, a novel, rapid semen analysis system with the potential to become a standard of care for the diagnosis and management of male infertility caused by oxidative stress. MiOXSYS® is commercialized outside the U.S. where it is a CE Marked, Health Canada cleared product, and Aytu is planning U.S.-based clinical trials in pursuit of 510k medical device clearance by the FDA. Aytu's strategy is to continue building its portfolio of revenue-generating products, leveraging its focused commercial team and expertise to build leading brands within growing markets.
