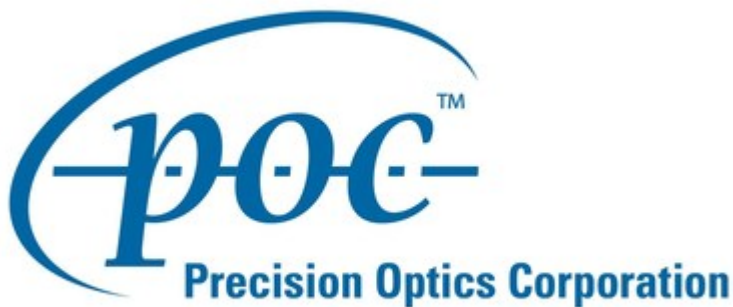


Precision Optics to Ring Nasdaq Opening Bell on Wednesday, December 14, 2022
